This Privacy Policy explains how portcontact.com ("the Platform" or "we") collects, uses, stores, and protects information related to users and visitors. By using the Platform, you agree to the terms described below.

1. Data Controller

2. Information We Collect

We collect only minimal information required for the operational functionality of the Platform. This may include:

- Contact information submitted via forms (e.g., email address, company name);
- Vendor quotations submitted in response to RFQs;
- Optional data provided during promotional or verification service applications.

We do **not** collect or store user account data, behavioral logs, or personal profiles unless explicitly provided by the user.

3. Purpose of Data Processing

All data is collected and processed exclusively for the following purposes:

- Forwarding RFQs to relevant vendors;
- Distributing vendor responses to the original requester;
- Operational management of promotional, visibility, and verification services;



• Compliance with applicable legal obligations.

Data is processed under the legal basis of **legitimate interest** (Art. 6(1)(f) GDPR) or with user consent where required.

4. Data Retention

• RFQs are **not stored** by the Platform beyond the time required for transmission.

• Vendor quotations may be temporarily retained for operational purposes but are not archived long-term.

• No tracking, logging, or profiling is performed on site visitors.

5. Use of Publicly Available Information

The Platform serves exclusively as a digital intermediary and passive conduit for the temporary forwarding of user-submitted content, including RFQs and vendor quotations. It does not verify, moderate, or validate the content, origin, or authority of submissions, and assumes no responsibility for the inclusion of vessel or company names used by third parties. Any such references are the sole responsibility of the original sender.

The Platform may collect and display publicly available information about maritime service providers, including company names, services, locations, and logos. Such data is published strictly for informational reference purposes.

We do not claim any partnership, affiliation, or endorsement unless explicitly stated.

We do not sell or rent any data. Data may be shared:

However, given the nature of forwarding-only operations, long-term storage risks are not applicable.

12. Children's Privacy
